

FLOWER MAGAZINE ANNIE SELKE “BRING THIS LOOK HOME” GIVEAWAY OFFICIAL RULES

Void outside the 50 United States, District of Columbia and where prohibited. Must be at least 21 years of age and a legal resident of, and located within, one of the 50 United States, or the District of Columbia, to win. TIMING: *Flower* Magazine Annie Selke “Bring This Look Home” Giveaway (“Sweepstakes”) begins at 12:00 p.m. Central Time (“CT”) on 3/15/2022 and ends at 11:59 p.m. CT on 3/31/2022 (“Sweepstakes Period”).

HOW TO ENTER: During the Sweepstakes Period, visit <https://flowermag.com/annie-selke-giveaway/> and follow the instructions provided to submit a completed online entry form to receive one (1) entry. There is no cost to register or enter.

ELIGIBILITY: This Sweepstakes is open to legal residents of the 50 United States and the District of Columbia, 21 years of age or older. Employees of *Flower* and Annie Selke, and their immediate family members (regardless of where they reside) or household members, whether or not related, are not eligible to enter or win. “Immediate family members” shall mean spouses, parents, step-parents, children, step-children, siblings, step-siblings, and their respective spouses. “Household members” shall mean people who share the same residence.
